Suffolk Public Schools

Purpose

The Special Education Advisory Committee is a regulatory committee that functions in accordance with Sections 300.650-300.653, Rules and Regulations for the administration of Public Law 105-17.

The Committee's functions are as follows:

- To advise the Suffolk Public Schools of needs in the education of children with disabilities;
- To participate in the development of priorities and strategies for meeting the identified needs of children with disabilities;
- To submit periodic reports and recommendations regarding the education of children with disabilities to the Suffolk Public Schools' superintendent for transmission to the local school board;
- To assist the Suffolk Public Schools in interpreting plans to the community for meeting the special needs of children with disabilities for educational services;
- To review the policies and procedures for the provision of special education and related services prior to submission to the local school board;
- To participate in the review of the Suffolk Public Schools' annual plan, prior to the submission to the School Board.

Membership

- Membership is approved by the School Board
- Comprised of representatives of stakeholder groups that have a common interest in meeting the educational needs of students with disabilities
 - Majority are parents of students with disabilities or individuals with disabilities
 - Community service providers
 - One Suffolk Public Schools teacher as required by
 Regulations Governing Special Education Programs for Children with Disabilities in Virginia
- The Director of Special Education and other Suffolk Public Schools staff may serve as consultants to the committee.

Focus areas include but are not limited to provision/availability of behavior regulation and sensory areas, classroom locations, restraint and seclusion training, and transition/work skills opportunities.
