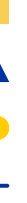

Exits/Entry Procedures



- ★ All visitors will use the buzzer at the Main Entrance to the building.
- ★ ID will be run through the Raptor Visitor Management System
- ★ Staff should enter through a designated entrance where a weapons detector is set up
- ★ All staff will go through the weapons detectors. This is non-negotiable.



Exits/Entry Procedures



Recess/Outdoor Activities

- ★ Students exiting the building will be adjusted to increase safety. Multiple security checks will be implemented.
- ★ Mirrors will be installed at designated exit doors to increase visibility
- ★ Any teacher taking students outside during the school day will have a radio
- ★ Designated staff will exit the building first, out of the designated exit, and will clear the area before anyone else exits
- ★ This staff will communicate with the SSO who is monitoring the cameras to ensure there is no suspicious activity on the school grounds
- ★ Once the area is cleared, the designated staff will radio to the teacher waiting to bring students outside to inform them the area is clear
- ★ School assigned SRO will train all staff in Situational Awareness



Building Security Measures



- ★ ZeroEyes Firearm Detection Software
- ★ Raptor Alert App
- ★ SSO Random Checks
- ★ SSO Checkoff Sheet for every random safety check of the building.
- ★ All classrooms should be closed and locked while class is in session



Critical Incident Response (CIR)



- ★ Response to CIR will be revised
- ★ Virginia Department of Criminal Justice Services' (DCJS) recommended protocol will be utilized
