A RESOLUTION OF THE SCHOOL BOARD FOR THE CITY OF SUFFOLK, VIRGINIA GRANTING THE SCHOOL SUPERINTENDENT THE AUTHORITY TO OBLIGATE THROUGH ENCUMBRANCE CONTRACTING ANY REMAINING APPROPRIATED FUNDS BEFORE THE END OF THE CURRENT FISCAL YEAR [JUNE 30, 2022] FOR CERTAIN DESIGNATED REPAIR AND/OR PURCHASING NEEDS OF SUFFOLK PUBLIC SCHOOLS

WHEREAS, pursuant to Virginia Code §22.1-89 (1950), as amended, local school boards manage and control funds made available to the school board for public schools and may incur costs and expenses; and

WHEREAS, pursuant to Virginia Code §22.1-100 (1950), as amended, all sums of monies derived from local funds unexpended in any year shall remain a part of the funds of the governing body appropriating the funds; and

WHEREAS, the final date for a local school board to expend unencumbered funds appropriated by the local governing body for fiscal year 2021-2022 before such funds revert to the local governing body is June 30, 2022; and

WHEREAS, there are certain repair and/or purchasing needs of Suffolk Public Schools that will require the expenditure of funds that must be made prior to June 30, 2022, to-wit; Up to 10 Buses - 77 Passenger with A/C; 6 Non-CDL buses with A/C; vehicles to replace white fleet (non-buses); additional cost of Fuel Tank installation at Florence Bowser Elementary School; Professional Painting at Creekside Elementary School and King's Fork Middle School; Sewage Pump Station at Nansemond Parkway Elementary School; Restroom partition replacements – Lakeland High School and Nansemond River High School; Turf Field – Nansemond River High School; Fire Lane and Parking Lot line painting -ALL schools; Replacement of 6-year old copiers -various schools; Hot water system valve replacements - various schools; Sinkhole repairs -various schools; Furniture replacement non-student -various schools and SAO; Furniture replacement student desks - various schools; Playground replacements – Mack Benn Jr. Elementary School and Oakland Elementary School; Camera scope of drainage field at KFHS to determine scope of remaining repairs, paving various school parking lots and early start playground replacements at several schools. and

WHEREAS, the School Superintendent should be granted the authority to obligate through encumbrance contracting any remaining appropriated funds before the end of the current fiscal year [June 30, 2022] for the following repairs and/or purchases to wit: Up to 10 Buses - 77 Passenger with A/C; 12 vans, 7 trucks, and 6 vehicles; Fuel Tank installation at Florence Bowser Elementary School; Professional Painting at Creekside Elementary School and King's Fork Middle School; Sewage Pump Station at Nansemond Parkway

Elementary School; Restroom partition replacements – Lakeland High School and Nansemond River High School; Turf Field – Nansemond River High School; Fire Lane and Parking Lot line painting -ALL schools; Replacement of 6-year old copiers -various schools; Hot water system valve replacements - various schools; Sinkhole repairs -various schools; Furniture replacement non-student -various schools; Furniture replacement student desks -various schools; Playground replacements – Mack Benn Jr. Elementary School and Oakland Elementary School; Camera scope of drainage field at KFHS to determine scope of remaining repairs, paving of various school parking lots, and Virginia Preschool Initiative playground replacement at several schools.


BE IT THEREFORE RESOLVED, the School Superintendent is hereby granted the authority to obligate through encumbrance contracting any remaining appropriated funds before the end of the current fiscal year [June 30, 2022]for the following repairs and/or purchases to wit: Up to 10 Buses - 77 Passenger with A/C; 6 Non-CDL buses with A/C; vehicles to replace white fleet (non-buses); additional cost of Fuel Tank installation at Florence Bowser Elementary School; Professional Painting at Creekside Elementary School and King's Fork Middle School; Sewage Pump Station at Nansemond Parkway Elementary School; Restroom partition replacements – Lakeland High School and Nansemond River High School; Turf Field – Nansemond River High School; Fire Lane and Parking Lot line painting -ALL schools; Replacement of 6-year old copiers -various schools; Hot water system valve replacements - various schools; Sinkhole repairs -various schools; Furniture replacement non-student -various schools and SAO; Furniture replacement student desks -various schools; Playground replacements – Mack Benn Jr. Elementary School and Oakland Elementary School; Camera scope of drainage field at KFHS to determine scope of remaining repairs, paving various school parking lots and early start playground replacements at several schools.

BE IT FURTHER RESOLVED that at the School Board's next regularly scheduled meeting of September 8, 2022 the School Superintendent shall report to the School Board all end of the year expenditures made pursuant to this grant of authority.
